PERMIT FEES. Before any permit required by this Ordinance shall be issued, the fees therefore must be paid. The amount of such fees, where not otherwise specifically fixed by this ordinance, shall be as follows:

If the estimated cost of the building structure or work for which permit is issued, is more than \$100.00 and does not exceed the sum of \$500.00 the fee shall be \$2.00

If more than \$ 500.00 and not more than \$1,000.00-----\$2.50

If more than \$1,000.00 and not more than \$2,000.00-----\$4.50

If more than \$2,000.00 and not more than \$3,000.00-----\$5.50

If more than \$3,000.00 and not more than \$4,000.00-----\$6.50

If more than \$4,000.00 and not more than \$5,000.00-----\$7.00

If more than \$5,000.00 and not more than \$6,000.00-----\$ 7.50

If more than \$6,000.00 and not more than \$7,000.00-----\$ 8.00

If more than \$7,000.00 and not more than \$8,000.00-----\$ 8.50

If more than \$8,000.00 and not more than \$9,000.00-----\$ 9.00

If more than \$9,000.00 and not more than \$10,000.00-----\$10.00

And for each \$1,000.00 or a major fraction thereof above \$10,000.00 the fee shall be \$1.00 additional therefore.

All fees shall be paid to the City Clerk.
